The Beth Din of The Vaad HaRabonim of Queens has summoned **Chaim Shapiro**, residing at [REDACTED] to the Beth Din for a *Din Torah* with the Claimant, **Devorah Leah Feigelstock**, for resolution of matters in dispute between them.

Chaim Shapiro was sent a first *Hazmana L'Din* on July 24, 2025, a second on July 31, 2025, a third on August 7, 2025 and a final *Siruv* Warning on August 14, 2025. However, **Chaim Shapiro** has not responded affirmatively to the Beth Din and has refused to participate in a *Din Torah* with the Claimant.

We therefore notify the public that the *Shulchan Aruch* (Code of Jewish Law) considers

Chaim Shapiro a *Mesarev L'Din*


חיים שפירא מסרב לדין
in contempt of the Beth Din

Therefore, halacha dictates that **Chaim Shapiro** is subject to all restrictions as stipulated in YD 334.

The Claimant may take any steps legally available to her to obtain relief. It is a great *Mitzvah* to encourage **Chaim Shapiro** to appear in front of the Beth Din for a *Din Torah* with the Claimant.
