William Roth, with an address of 146 Rutledge Street, Brooklyn, NY, has been summoned to the Beth Din of America by Nechama Roth regarding her request for a Jewish divorce (*Get*).

William Roth has failed to appear in front of the Beth Din of America or an alternative Beth Din for the purpose of giving a *Get* or submitting to Beth Din adjudication of Nechama Roth's request for a *Get*.

William Roth is thus deemed a *mesarev lavo ledin*, one who declines to appear in front of the Jewish courts according to Jewish law and Nechama Roth is free to pursue any remedies permitted by secular law.

HASRA'OS SERUV (WARNING OF ISSUANCE OF CONTEMPT ORDER)

Dear Mr. Roth:

Three *hazmanot* (summonses) have already been sent to you from the Beth Din of America in the matter of a Jewish divorce between yourself and Nechama Roth. Jewish law requires that you respond to the *hazmanot* of the *beit din*, including the most recent summons dated November 28, 2012.

Although you previously advised the Beth Din that you were prepared to have your case adjudicated by the Beis Din of Mechon L'Hoyroa, the Beis Din of Mechon L'Hoyroa has advised us that, to date, you have failed to appear before that beis din for a hearing in this matter.

Failure to respond properly to the summons of the Beth Din (see Section 2 of the Rules and Procedures of the Beth Din, available online at www.bethdin.org, for a description of acceptable responses) by January 14, 2013 will result in the issuance of a public order of contempt (*sh'tar seruv*) from the Beth Din in accordance with principles of Jewish law. The contempt order may subject you to any actions within the parameters of *halakha* deemed appropriate as a result of your failure to respond to Beth Din.

Dear Mr. Roth:

As you know from our prior correspondence, we have been contacted by your wife, Nechama Roth, who would like our Beth Din office to schedule a *din torah* to resolve all end of marriage issues between you including the Jewish Divorce (*Get*). We may share your response to this summons with Ms. Roth.

In response to our first *hazmana*, dated June 27, 2012, we received a letter from Rabbi Aharon Bentzion Mandel indicating that you were prepared to appear before any of the following *batei din*: *Machon Lihoyra'ah*, *Hisachdus Harabbonim*, or *Tartikov*. Ms. Roth has indicated to us that she is prepared to appear before the *batei din* of *Machon Lihoyra'ah*. We have attempted to communicate this to you so that you and Ms. Roth may initiate proceedings before the *batei din* of *Machon Lihoyra'ah*, however neither you nor Rabbi Mandel have responded to our phone calls or facsimile transmissions over the course of the past few weeks.

This is the third summons we are sending to you and Jewish law requires that you respond to the summons of the beth din. If you do not respond, you may be subject to a *sh'tar seruv* (contempt order of the beth din) and its consequences. We ask you to respond to this summons no later than December 5, 2012. 
Dear Mr. Roth:
